Exhibitor Liability Insurance Program

As a standard requirement for all our show exhibitors, it is necessary for you to carry general liability coverage from an insurance company in good standing with minimum policy limits of \$1,000,000 per occurrence and \$2,000,000 aggregate. Insurance Coverage is not optional.

This insurance must be in force during the lease dates of the event, March 12-15, 2025 naming Florida Swimming Pool Association (2555 Porter Lake Dr., Suite 106 Sarasota, FL 34240) as the certificate holder. The following must be named as additional insured: Florida Swimming Pool Association and Orange County Convention Center West Hall E.

Florida Swimming Pool Association has requested that Rainprotection serve as their insurance management company. Inaddition to being able to provide vendors with insurance, we are also collecting and verifying that all insurance certificates, regardless of the insurer, are verified for compliance
